### **Marqueta Welton – Chair**

Marqueta Welton was appointed to Chief of Staff for the North Carolina Department of Commerce in March 2021. She supports the agency's mission of improving the economic well-being and quality of life for all North Carolinians through oversight of central operations and management of programs for economic development, grants and incentives, science and technology innovation, and development of the state's clean energy resources. ### **Jen Banks**

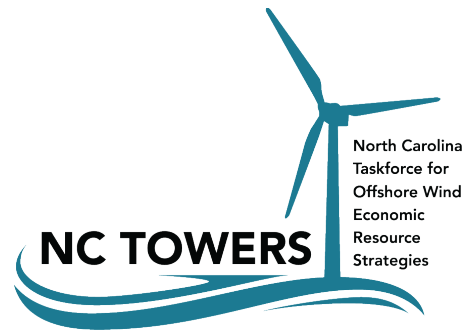

### **Brian Clark**

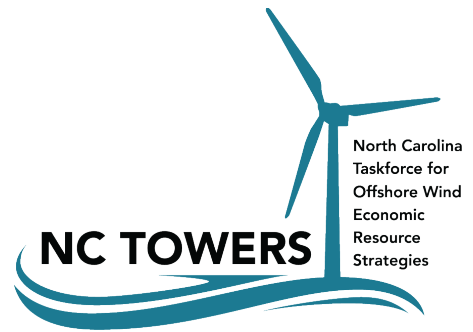

#### **Hayes Framme**

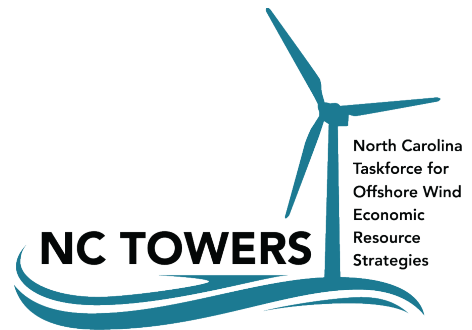

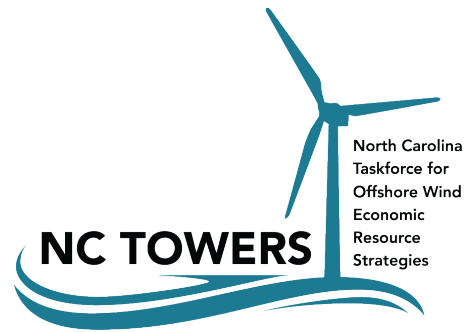
### **Perry Harker**

### **Stephen (Steve) Kalland**

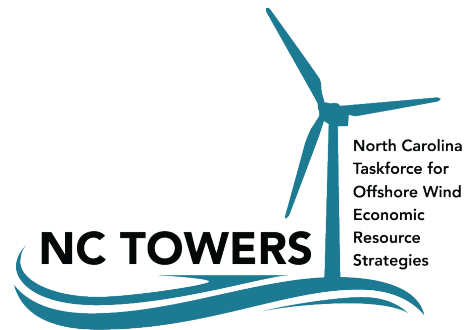

Munashe lives in Durham with his wife and their two dogs.

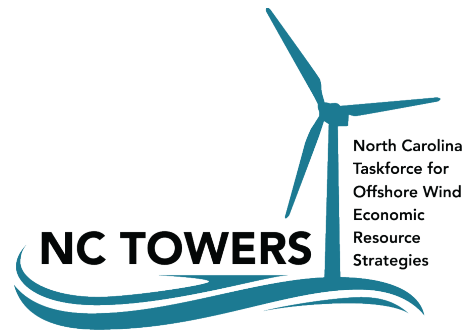
### **Secretary Grier Martin**

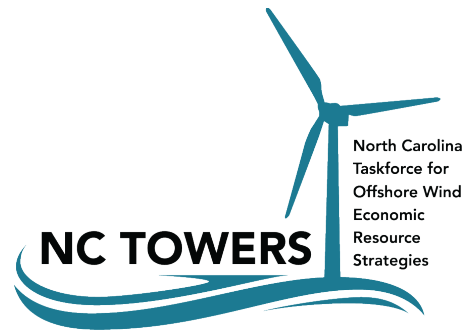

### **Bob Peele**

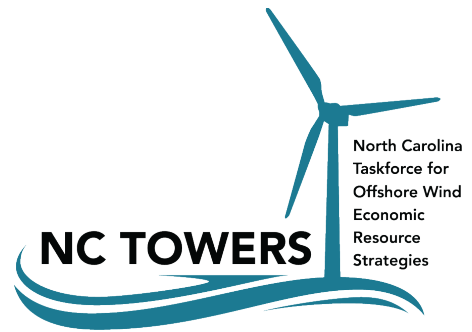

He has a staff of 18 employees and a budget of \$9.5 million, which consists of State and federal grant funding.

Mr. Richardson was appointed to the Historically Underutilized Business (HUB) Advisory Council on November 2, 2017, by Governor Roy Cooper.

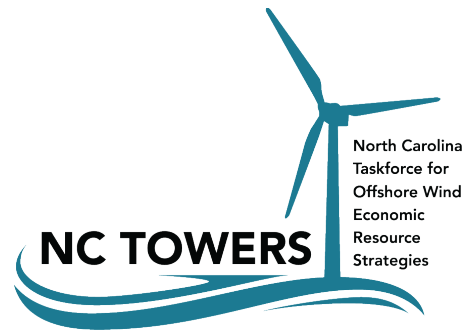

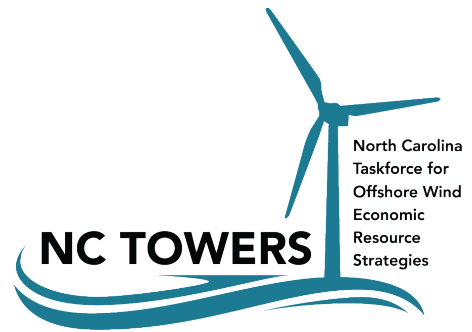
### **Glenn Skinner**

### **Alvin Warwick**

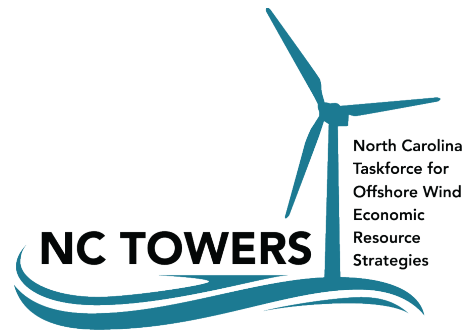
Alvin Warwick is the Business Manager for the International Brotherhood of Electrical Workers, Local 342.
