N.C. Rural Infrastructure Authority Board Approves Second Round of Grants

N.C. Commerce Secretary Sharon Decker and Assistant Secretary for Rural Development Dr. Pat Mitchell announced March 27 that the N.C. Rural Infrastructure Authority (RIA) approved 18 grants totaling more than \$8.1 million.

The RIA was established as part of the Rural Economic Development Division at the N.C. Department of Commerce to assist with the review and approval of grants for rural areas in the state. The grants-making programs of the new division include assistance for building reuse and restoration as well as infrastructure including water and sewer.

Grants were announced in four program areas: Community Development Block Grants (CDGB), the Industrial Development Fund Utility Account, the Building Reuse Program, and the Economic Infrastructure Program.

The CDBG is a U.S. Housing and Urban Development (HUD) program that provides an annual allocation of funds to the State for rural economic development and residential infrastructure projects. The Department of Environmental and Natural Recources administers the rural residential infrastructure program and the N.C. Department of Commerce administers the economic development program. CDBG economic development provides grants to local governments for creating and retaining jobs. Funding for projects is based on the number of jobs to be created and the level of distress in the community applying for the funds.

The Utility Account of the Industrial Development Fund provides grants to units of local government of the 80 most distressed counties in the state to assist in job creation. The funds may be used for publicly-owned infrastructure and should be used for projects that are reasonably expected to result in the creation of jobs.

The Building Reuse Program will provide grants/loans to local governments to support the reuse of vacant buildings and/or expand rural healthcare facilities that will lead to the creation of new, full-time jobs.

The Economic Infrastructure Program will provide grants for a variety of public infrastructure, such as water and sewer, broadband infrastructure, natural gas, access road, and rail

Plastics Manufacturer to Expand in Henderson County

Governor Pat McCrory and N.C. Commerce Secretary Sharon Decker announced March 31 that Elkamet Inc. is expanding its North Carolina manufacturing operations in Henderson County. The company plans to create 20 new jobs and invest more than \$2.5 million over the next three years in East Flat Rock. <u>Bill Payne</u> served as the developer on the project for the N.C. Department of Commerce.

"We are continuing to make North Carolina a destination to grow a business through jobsfriendly economic policies," said Governor McCrory. "I applaud Elkamet for choosing Henderson County for their expansion, and we look forward to working with them as a strategic partner."

Elkamet Inc. produces extruded profiles from industrial polymer materials for the automotive industry as well as PA/PE/XPE tanks for fuel and hydraulic systems which are used in utility vehicles and motorcycles. Elkamet currently employs 54 full-time workers in western North Carolina.



At its four sites across the world, Elkamet employs more than 700 staff, including 77 trainees and participants on the dual study program "StudiumPlus." "The consideration of our East Flat Rock location for this project is based on a very committed and fast-learning workforce out of Henderson County," said Artur Bitner, plant manager, Elkamet Inc.
