Governor Cooper Announces UPS Will Launch 592-Job Expansion in N.C.

UPS, the multinational package delivery and supply-chain management company, will add 592 jobs in Guilford and Alamance counties, **Governor Roy Cooper** announced today (October 13). The company plans to invest a total of \$316.4 million at two sites over the coming four years.

Earlier this morning, **North Carolina Commerce Secretary Anthony M. Copeland** led a socially-distanced event in Greensboro to celebrate the project.

"The pandemic highlights that supply chain management and delivery services are critical during a crisis. These two expansions are a bold investment that add up to hundreds of jobs and millions in investment across North Carolina," said **Governor Cooper**.

"UPS appreciates the State of North Carolina for their support of these projects that will help UPS move our world forward by delivering what matters. The new and expanded facilities will increase the speed and flexibility for connecting businesses and customers throughout the state, across the country and around

International Snack Food Company to Invest \$24 Million in Kings Mountain

Benestar Brands, an international snack food manufacturer, will create 129 jobs in Cleveland County, **Governor Roy Cooper** announced today (October 13). The company will invest \$24 million to establish a new production facility in Kings Mountain.

"Even during a pandemic, companies like Benestar Brands can expand operations because of our strong workforce, quality transportation network and management of this crisis," said **Governor Cooper**."

Benestar Brands, the parent company of Evans Food Group, is a rapidly growing snack food manufacturer focused on better-for-you, high-quality snacks. The newest project in North Carolina will provide easier access to the fast-growing company's customer base and the nation's east coast market. This new facility will support Benestar Brands' expansion plans into new snack categories.

"After an extensive search throughout the southeast, we selected Kings Mountain, North Carolina for our newest production facility based on the state's strong support of the manufacturing industry and talented workforce," said **Carl E. Lee, Jr., CEO of Benestar Brands**. "Over the past year, our company has expanded our portfolio of innovative savory snacks, entering new categories that will be produced at this Plant. We look forward to an ongoing partnership with the State of North Carolina as we expand our company."

"Today's decision by Benestar Brands shows that North Carolina is a prime destination for companies of all kinds striving to innovate and

the globe," said **Derrick Johnson, president of UPS's South Atlantic District**. "This is an exciting time to be part of North Carolina's economic growth and we look forward to bringing additional jobs that pay well to the Greensboro area as a partner in the community."

UPS will expand its existing Greensboro hub with the addition of 141 new jobs and construct a new package car center at the N.C. Commerce Center in Graham, creating 451 jobs there.

New positions at both facilities will come with wages averaging \$65,147 per year, creating a total annual payroll impact of \$38.5 million for the region.

"The COVID-19 pandemic is changing the nature of global supply chains, and today's news is early evidence that North Carolina is positioned well for the future," said **Secretary Copeland**. "UPS is an iconic name in logistics and their expansion will impact the state's economy and business community in a number of very positive ways."

UPS's North Carolina expansion will be facilitated, in part, by a Job Development Investment Grant (JDIG). Over the course of 12 years, the project is estimated to grow the state's economy by more than \$1.4 billion.

Using a formula that takes into account the new tax revenues generated by the new jobs, the agreement authorizes the potential reimbursement to the company of up to \$10.23 million over 12 years.

The company's JDIG agreement will also result in as much as \$1.14 million in new funding for the state's Industrial Development Fund - Utility Account. The Utility Account helps rural and economically distressed communities finance infrastructure upgrades necessary in attracting job creation and investment.

The [North Carolina Department of Commerce](#) and the [Economic Development Partnership of North Carolina](#) led a collaborative effort to bring UPS's expansion to North Carolina. Also partnering in the project were the [North Carolina General Assembly](#), the [North Carolina Community College System](#), [Alamance County](#), [Guilford County](#), [City of Greensboro](#), [City of](#)

grow market-share," said **Commerce Secretary Anthony M. Copeland**. "Our state has the assets and amenities to support growing companies realize their strategic objectives."

The average annual salary for all new positions is \$43,021, creating a payroll impact of more than \$5.5 million per year. Cleveland County's overall average annual wage is \$40,019.

Benestar Brands was awarded a Job Development Investment Grant (JDIG) with a potential reimbursement to the company of up to \$1,212,000 over 12 years. Projects supported by JDIG must result in positive net tax revenue to the state treasury, even after taking into consideration the grant's reimbursement payments to a given company.

Governor Cooper Announces Merchants Distributors Will Expand and Create 111 Jobs in Hickory

Merchants Distributors, LLC, a wholesale grocery distributor founded in Hickory in 1931, will invest \$120 million to expand its services and operations, creating 111 jobs, **Governor Roy Cooper** announced September 30.

"Companies with roots in our state like Merchants Distributors understand North Carolina's advantages for their business," said **Governor Cooper**. "It's great to see a home-grown company, which could expand anywhere, once again choose our state and our workers to expand."

Merchants Distributors (MDI) and its parent company Alex Lee, Inc. were founded in Hickory and maintain headquarters there, distributing both food and non-food grocery items to more than 600 retail stores across

Nestlé Purina PetCare Will Create 300 Jobs in Rockingham County

Nestlé Purina PetCare Company, the leading pet care company in the United States, plans to establish significant new manufacturing and distribution operations in Rockingham County that will become operational in 2022 and create up to 300 new jobs by 2024, **Governor Roy Cooper** announced September 30.

The company will invest \$450 million in a 1,300+ acre site near Eden that formerly housed a brewery, where it will manufacture and distribute Purina pet food.

"North Carolina's manufacturing workforce is strong, and this announcement is an important new phase in Nestlé Purina's growth," said **Governor Cooper**. "This company's global reputation for quality products, innovation, sustainability, and corporate citizenship fits well with our state's workforce, economy, and the business community."

Headquartered in St. Louis, Purina has been a trusted name among U.S. pet owners for nearly a century. Its brands include Purina ONE, Pro Plan and Dog Chow and Tidy Cats. The company's sales totaled \$9.4 billion in the Americas in 2019, and it employs more than 8,000 workers across 21 U.S. production sites. Since 2001, Purina has been part of Nestlé S.A., a global leader in nutrition, health and wellness based in Vevey, Switzerland.

"Eden is Purina's first manufacturing operation in North Carolina, and through this expansion we build on our more than 90-year history of making science-based dog and cat foods that pet owners trust," said **Nina Leigh Krueger, President, Nestlé Purina U.S.** "Despite the challenging times we have all been living in, Purina has remained resilient. This strategic and long-term investment demonstrates our commitment to providing high-quality nutrition for pets. We're thankful for the great partnership at the state and local levels, and we are excited to be a part of this community now and for many years to come."

the United States and other locations. The company's new project in Caldwell County will renovate and expand the company's existing facility in Hickory, including the installation of sophisticated logistics technology and automation to support rapid growth of the business.

"We are excited to continue to grow in Hickory where we were founded nearly 90 years ago," said **Brian George, Chairman and CEO of Merchants Distributors**. "The quality of life and the business support from North Carolina and our local community makes Hickory an ideal location to continue to grow our business."

"Nearly 90 years ago, Moses George – a Lebanese immigrant – and his two sons started this company with two trucks and 12 employees," said **North Carolina Commerce Secretary Anthony M. Copeland**. "Through hard work and vision, and a supportive environment for their business, this family built a company that now employs more than seventeen hundred people in North Carolina. It's an inspiring, North Carolina story."

Although wages for the new jobs will vary depending on position, the average salary will be \$51,634, above the current average wage in Caldwell County of \$40,124. The state and local area will see an additional impact of more than \$5.7 million each year from the new payroll.

A Job Development Investment Grant (JDIG) worth up to \$1,344,000 spread over 12 years will help facilitate the project.

Adventure Gear Manufacturer to Invest \$1 Million, Bring 70 New Jobs to Old Fort

Triple Aught Design, a US-based adventure gear company, will create 70 new jobs in McDowell County, **Governor Roy Cooper** announced October 2. The manufacturer will invest \$1 million to build and operate a cutting-edge apparel and gear production

"Today's announcement by Nestlé Purina marks a new beginning for this property and for the people of Eden," said **Commerce Secretary Anthony M. Copeland**. "The significant investment this global company is about to make here during this historic pandemic speaks forcefully about the safety, resilience and reliability of North Carolina as an international business destination."

Nestlé Purina PetCare's project will be facilitated, in part, by a Job Development Investment Grant (JDIG). Over the 12-year term of the grant, the project is estimated to grow North Carolina's GDP by nearly \$2 billion. Using a formula that takes into account new tax revenues generated by the 300 new jobs, the JDIG agreement authorizes a potential reimbursement to the company of up to \$4.31 million over 12 years. The company's operations are projected to generate \$61.23 million in state tax revenue over the life of the grant.
