

	Subject: Revised Local Workforce Innovation and Opportunity Act (WIOA) Workforce Development Program Year 2018 Allocations

Purpose: To revise Workforce Innovation and Opportunity Act (WIOA) Program Year (PY) 2018 Local Area October Allocations.

Background: The U.S. Department of Labor released Workforce Innovation and Opportunity Act Allotments for PY 2018 (July 1, 2018 – June 30, 2019) for Adult, Dislocated Worker, and Youth Activities in Training and Employment Guidance Letter (TEGL) No. 16-17. The state allotments are based on funds appropriated to the U.S. Department of Labor by the United States Congress through the Consolidated Appropriations Act, 2018, Public Law 115-141 on March 23, 2018. Training and Employment Guidance Letter (TEGL) 16-17, Change 1 restores the set aside for evaluations to the funding available to states in October 2018.

Division H, Title I, sec. 107 of the Consolidated Appropriations Act, 2018, allows the Secretary of Labor to set aside a portion of the Adult and Dislocated Worker grant funds for evaluations. The Department has decreased the amount of funds it plans to set aside for this purpose and has restored the remaining funding to the state allotments. The base portion (available July 1, 2018) of PY 2018 funding for Adult and Dislocated Worker activities was not impacted by this restoration. Also, the WIOA Youth Activities funds (available April 1, 2018) were not affected.

The attached charts provide the revised October portions of the PY 2018 Local Area WIOA Adult and Dislocated Worker allocations. Also, included for convenience, is the original Chart for Youth allocations, which has remained unchanged.

Action: The attached revised allocation charts are to be used for planning and operating PY 2018 Workforce Innovation and Opportunity Act Title I Programs under the PY 2018 Local Workforce Development Board Plans.

Local Workforce Development Boards will be administered the October portion of funds through the Workforce Information System Enterprise (WISE) system when received by the Division.
