Purpose: To transmit Program Year (PY) 2014 Local Area Allocations.

Background: The U.S. Department of Labor released Workforce Investment Act (WIA) Allotments for PY 2014 (July 1, 2014 – June 30, 2015) for Youth, Adult, and Dislocated Worker Activities in Training and Employment Guidance Letter (TEGL) No. 18-13. The state allotments are based on funds appropriated to the U.S. Department of Labor by the United States Congress.

The attached charts provide the July and October portions of the Program Year 2014 Local Area Adult and Dislocated Worker allocations and the full Youth allocation. Allocations reflect the 'hold harmless' provisions applicable to Adult and Youth funds. Hold harmless provisions provide that Local Workforce Development Areas shall not receive an allocation percentage for a fiscal year that is less than 90% of the average allocation for the two preceding fiscal years. There is no hold harmless provision for Dislocated Worker funds.

Action: The charts are to be used for planning and operating Program Year 2014 WIA programs under the PY 2014 Local Area Plans.
